LIABILITY RELEASE

IN CONSIDERATION of being given the opportunity to participate in Vashon Island Rowing Club ("Club") Activities, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature and risk of activities, both on water and land-based, and that I am qualified, in good health, and in proper physical condition to participate in such Activities.

2. REPRESENT that I am a competent and confident swimmer and can tread water for 10 minutes.

3. FULLY UNDERSTAND that: (a.); **ATHLETIC ACTIVITIES INVOLVE RISKS AND DANGERS.** (b.) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the activity, the conditions in which the activity takes place, the condition of equipment used in the activity, or the negligence of the releasees named below; (c.). and **I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES** I incur as a result of my participation..

4. AGREE AND WARRANT that I will examine and inspect each of the activities in which I take part as a member or guest of the Club and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge and will refuse to take part until the condition has been corrected to my satisfaction.

5. HEREBY RELEASE, discharge, and covenant not to sue USRowing, the Club, their administrators, directors, agents, officers, volunteers and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the activities take place, (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, **I WILL INDEMNIFY, SAVE AND HOLD HARMLESS** each of the Releasees, from any litigation expenses, attorney fees, loss, liability, damage, or costs which any may incur as a result of such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
